Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.nvosha.com and Bilingual Safety Training and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Bilingual Safety Training include www.nvosha.com and BST. The BST website is a online training site. By using the BST website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, BST may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address

If you purchase BST's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. Sharing Information with Third Parties

BST does not sell, rent or lease its customer lists to third parties.

Tracking User Behavior
